Objective of the Micro and Small Enterprise Cluster Development Program (MSE CDP) / Maharashtra State Industries - Cluster Development Program (MSI CDP) is to support the sustainability and growth of MSEs by addressing common issues such as improvement of technology, skills and quality, market access, access to capital, etc. to set up common facility center for testing, training center, raw material depot, effluent treatment, complementing production processes, etc. Following are the main activities involved in the process of Cluster Development program:

a. Preparation of Diagnostic Study Report:

Diagnostic study report is required to map the business processes, do a SWOT analysis and identify the needs of the cluster and propose remedial measures within a validated action plan. Wisecon supports cluster members for preparation, submission and presentation of DSR with Soft Intervention Program to Directorate of Industries, Mumbai for validation.

b. Soft Intervention Program:

Soft intervention program involves Technical assistance, Capacity building, exposure visits, Market development, Trust building etc. for the cluster units. Wisecon assists in design of Soft Intervention Program & it's Submission to Directorate of Industrywies, Mumbai for validation and also in its effective implementation.

c. Preparation of Detailed Project Report:

Detailed Project Report (DPR) is required to evaluate the technical feasibility and financially viability of the project for setting up of a common facility center for a cluster of MSE units and / or infrastructure development project for new industrial estate / area or for upgradation of infrastructure in existing industrial estate/ area/ cluster. Wisecon supports in the preparation and presentation of Diagnostic Study Report, Soft Intervention Program, and Detailed Project Report before various government authorities at the District, State and Central level and end to end support until the formation of the Cluster.
